You acknowledge the following:

- ✓ While at Misty Glen Day Camp/Dog Hotel your dog(s) will be current on vaccinations for rabies, bordetella, distemper, parvo, and flea & tick control. We strongly recommend canine influenza vaccine and heart worm protection, but at this time do not require it for day care or boarding.
- ✓ If your dog is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, spitting up white foam or vomiting, lethargy blood in urine or stool or diarrhea, or is being treated for parasites of any kind you will not bring your dog to day care or boarding at Misty Glen.
- ✓ Emergency Medical Care: Reasonable effort will be made to contact you in the event your dog needs medical care. If we cannot reach you, we will make reasonable effort to contact your emergency contact and/or veterinarian listed on this form. If we cannot reach you or contact provided by you, we make the judgement whether an alternate veterinarian or an emergency clinic other than your veterinarian is necessary. We have your expressed permission to administer basic first aid, if necessary, and to transport your pet for veterinary care, whether with your vet or an alternate vet.
- ✓ You agree to be solely responsible for the payment of all medical bills for your dog(s) and you release Misty Glen Kennel LLC, its officers, directors, agents, volunteers and employees of and from any and all responsibility for, or claims, damages, debts arising out of or related to such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.
- ✓ You acknowledge that Misty Glen facility is a specialty facility enjoyed by healthy, non-aggressive dogs. If your dog has exhibited aggression or bite behavior in the past towards humans or dogs, we can suggest an alternate boarding situation. If your dog exhibits aggressive or unruly behavior or exhibits signs of contagious illness while at Misty Glen such that in our judgement poses a danger to our staff or other dogs, your dog may be picked up upon our request.
- ✓ You acknowledge that the staff at Misty Glen are not veterinarians or vet technicians. We cannot diagnose medical conditions at the kennel. If you ask that they administer medications, they will do so as you instruct and to the best of their capabilities.

- ✓ You acknowledge and understand that there are certain risks involved in day care and boarding, including but not limited to dog fights, dog bites to humans or other dogs, cuts, scrapes, serious injury or even death, and the transmission of disease. Any medical expenses will be your responsibility and you release Misty Glen kennel LLC of any charges.
- ✓ If your dog has allergies we make reasonable effort to ensure that they do not come into contact with that allergen. You acknowledge that this is not always possible when your dog is placed in a communal environment such as a day care or kennel.
- ✓ Misty Glen Kennel cannot guarantee that any belongings brought to the kennel will be returned in the same condition and items may be lost and not returnable. We ask that you bring your dog collared, on a leash, along with food, any necessary medicines and treats. We do not accept beds, toys or long-lasting treats such as rawhide, bones, antlers or large blankets.
- ✓ Misty Glen reserves the right to change your dog's type of kennel arrangement if we believe it is necessary to protect the health and well-being of your dog, other dogs or our staff. This may result in a higher cost to you.
- ✓ You acknowledge that there is no staff within the facility overnight.
- ✓ Payment is due upon pickup of your dogs. We accept cash, credit card, debit card and check. Misty Glen receives the right, without notice to adjust our fees and services between stays. Please inquire at the front desk as to our current fees.
- ✓ By checking this form you have in like signed your signature to indicate your agreement with all of the terms listed hereof.
- ✓ You release, indemnify and agree to hold Misty Glen Kennel harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, cause of actions or suits, whatsoever in law or equity (including, without limitation, attorney's fees and related costs: arising out of or related to the services provided by Misty Glen Kennel, except which may arise from the sole gross negligence or intentional and willful misconduct of Misty Glen Kennel, including, without limitation, (i) any inaccuracy or any statement made by yourself or information provided by you to Misty Glen Kennel (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.
- ✓ This agreement covers the current relationship between Misty Glen Kennel LLC and yourself. Each time your dog(s) is in day care or boarding at Misty Glen Kennel now and in the future you affirm the terms of this Agreement and the truthfulness and accuracy of all statements you make in this Agreement.
